AN ORDINANCE TO AMEND ORIGINAL ORDINANCE NUMBER 986 REGARDING THE BOARD OF DIRECTORS, APPOINTMENT, TERM OF OFFICE, VACANCIES AND RULES OF THE LARAMIE DOWNTOWN DEVELOPMENT AUTHORITY

WHEREAS, the Council for the City of Laramie (City) established by ordinance the Laramie Downtown Development Authority on August 9, 1989; and

WHEREAS, the requirements for Board membership were outlined as permitted by Wyoming Statutes and adopted by city ordinance; and

WHEREAS, Wyoming Statutes permit an officer or director of a corporation having its place of business in the downtown development district as eligible for appointment to the board; and

WHEREAS, the Downtown Development Authority Board is recommending that the following areas, as each has requested, be included in the district boundary:

James Rinehart (Owner), Western United Realty  
Laramie Plains Association (Owner), Laramie Plains Museum  
Albany County Commission, Courthouse  
501 Garfield LLC (Owner), Pence and McMillan LLC  
ACE COAPT Realty LLC (Owner), Ace Hardware & Advanced Auto Parts

NOW BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LARAMIE:

**Section 1.** Original Ordinance No. 986 is hereby amended as follows in *Section 2. Board of Directors; Appointment; Term of Office; Vacancies; Rules (a)* to include this language:

An officer or director of a corporation having its place of business in the downtown development district shall be eligible for appointment to the board.


**Section 2.** The boundaries of the Downtown District as described in Original Ordinance No. 986 Section 3 are amended to read as outlined in Attachment A.

**Section 3.** Original Ordinance No. 986 is hereby amended as follow in *Section 4. Budget Review and Approval; Financial Reports (b)* to include this language:


Receipts and disbursements of the Downtown Development Authority may be handled by the Treasurer appointed by the Downtown Development Authority Board.

**Section 4.** The effective date of this Ordinance shall be immediately upon enactment and publication as provided by law.

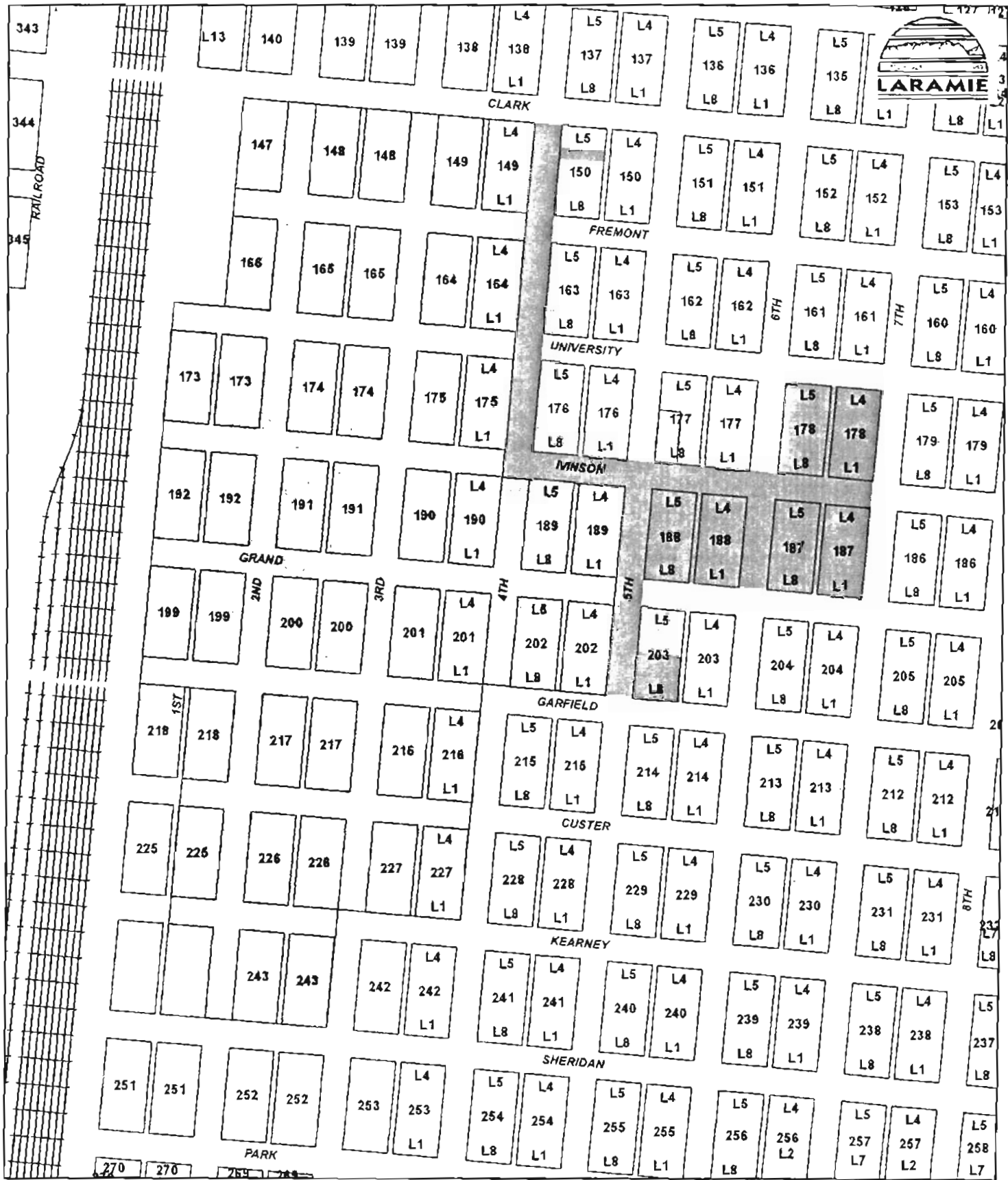

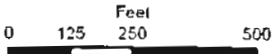
